2. DECLARATIONS OF INTEREST

There were no declarations of interest.

3. MINUTES OF MEETING HELD ON 25.11.04

p.285 Change the name 'Territt' to 'Terret'. The Minutes were then passed as correct.

4. MATTERS ARISING THEREFROM

a.p.285 item 4a. The Notice board at the end of Mickley Lane is now in use.

b.p.286 item 3 Council Tax Consultation.

Cllr. M. Leigh will circulate minutes of this meeting when received. In the meantime County Cllr. Reid summarised the results for the Parish Council.

c. p.286 Item 4, 'The Town and Parish District Council Meeting' was attended by Cllr. H. Crouch and Cllr. J. Higgins.

They reported that the meeting had been interesting and informative.

It had pointed out the fact that Rutland was a comparatively 'safe place' as compared to others parts of the area.

The Councillors thought that the Parish Council should be aware that Rutland could be neglected because it was thought of as being 'safe'. They were concerned that the Rapid Response vehicle should be maintained in the Oakham area. As far as can be ascertained the vehicle is to be situated in Oakham for the foreseeable future.

- d. p.288 item 2. The date for the Parish Council Service has still to be negotiated. It is hoped to be later in the Spring.
- e. p.285 item d. Cllr. R. Wright raised the question of the 'Car Port' that has been erected on the Old Hall with County Cllr. Reid. She is still trying to ascertain whether there has been permission for this to be erected. There has not been a satisfactory answer from the enforcement officer to this question. County Cllr. Reid said he would raise the matter and get an answer for her.

5. CORRESPONDENCE

- 1. The C.A.B. are asking for permission for any contribution made by the Parish Council to be placed in the new CAB Co. Registration No. 05287678

- 2. A letter has been received from Mrs Holford, the Secretary of to the PCC regarding the village Notice boards. She felt that the Notice boards have been reduced and that there isn't enough room on them and they weren't situated in the correct positions. The Council asked the Clerk to reply stating that the notice boards belonging to the village have not been decreased in fact the amount of room on the notice boards has been increased. There are three notice boards, one at either end of the village and one in the centre, which means that the whole village has access to a notice board. As the Council has just re-sited a notice board to the end of Mickley Lane they do not have any plans just at present to supply further boards. The Church is welcome to supply one of its own. The Chairman suggested the matter could be reviewed in six months time.
- 3. A letter concerning 'The Freedom of information act' has been received from the Office of the Deputy Prime Minister. It states that the following officers as the qualified persons for the purposes of section 36 of the Freedom of information Act 2000 to the parishes in England are an Authority - Parish & Town Councils,

Primary Authorisation - Clerk to the Council, Secondary authorisation - Chairman of the Council. This was duly noted.
- 4. The Council has been asked to send a donation supporting 'Prides Alarm Charity'. Cllr. Crouch reported that there was another local system in operation in Rutland and that the Council would do better to support this system. This was agreed.

5. The Parish has been asked if they were interested in finding somewhere in Langham to house , a bottle bank and or facilities to collect materials for recycling. After discussion it was decided to ask the 'Wheatsheaf' public house licensee if he would be willing to have the bottle bank reinstated or the 'Vintners' in Burley Rd. whether they would be willing to host them. The council did not think that there would be any room for other recycling facilities and that most people use the facilities at the Tesco or the Co-op car parks.
6. It was proposed that the Council should subscribe to the 'Clerks and Councils Direct' magazine at the cost of £7.50.

Mr Frisby, the Chairman of the Langham Gardeners Association has reported that the entrance to the allotments at the Burley Rd end had been damaged due to the work that has been carried out on the recreational field. This was discussed and it was agreed to tidy up the area and that the field gate is to be reinstated. It was also agreed that if the 'field gate' belonging to the council that is at the end of the Rookery Footpath is not the correct size to be used a new one should be purchased.

8. 'VISION 2010'

This is the review of all schools in the Rutland Area. It was reported that Langham School will remain but there might be re-siting in the future. There are three secondary schools in Rutland. They should, under the Government initiative all be rebuilt by 2016. After much lobbying The Vale of Catmose school will be rebuilt in the first phase of this rebuilding which means it will be totally rebuilt in the near future.

9. REPORTS OF MEETINGS ATTENDED BY MEMBERS

A.

Cllr. R. Hosmer attended the APC meeting. He reported that the granting of a Quality Parish Council status was discussed. To obtain this status the Clerk must be qualified which takes about three years of study. This involves expense which could be offset by, when qualified, a £10,000 grant to the Parish Council. Langham cannot at present qualify as one of the conditions of application is that all the Councillors of the Parish Council have to be elected and not co-opted and that the Clerk has to be qualified. The Chairman observed that he thought that Langham Parish Council was a Quality Parish Council, which was generally agreed.

B.

The School Governors Meeting.

The Governors reported that they are trying to find some solution that could help with the congestion at the arriving and departure times of the school pupils. It has been suggested that the residents of Langham could be asked whether they were willing to loan their driveways during this period, thus freeing up the Burley Rd area. It was understood that the immediate roads in the Burley Rd area are to be canvassed for their support.

10. ANY OTHER BUSINESS

- i. The Recreational Group have now finished installing the equipment and this is ready for inspection. The equipment is already insured for use.

It was proposed that Leic. Playing field Association should be given permission to give the initial inspection at the cost of £ 100.

A rota of volunteers to give the equipment a weekly inspection is to be drawn up and it is proposed that a list of 'inspections points' should be handed to each volunteer to check, the completed list should then be signed and dated and handed to the Clerk for safe keeping. This will be set up before the equipment is put in use.

The Chairman thanked the Recreational Group for all their hard work the results of which they could be justifiably proud.

The proposed opening of the date for the new equipment is to be March 9th. It is hoped that the local MP. Alan Duncan will attend. Refreshments will be served. One of the requirements of the grants is that the recipients should advertise what has been achieved by the Grants

The Group is hoping to purchase a 'Langham Tower' for the younger people and by request 2 picnic benches with any surplus money. There will be other activities in the village where it is hoped to raise more money towards the upkeep etc. of the 'playing field'

The Chairman suggested that the Parish Council should host a 'thanks party' for the volunteers to show our appreciation to all participants. This was warmly received.

- ii. There has been a request that more 'dog fouling' notices should be put on the gates going into the 'Wild Life Area' and the 'Playing field' as the large ones already there are not being observed.
- iii. County Cllr. Reid was asked to look into the matter of the dangerous wall at the end of Ruddle Way. This a recurring cause for concern. The RCC is aware of the problem but are not finding it easy to ascertain formal consent from the owners. He has however managed to get 2 bollards erected at the end of Cold Overton Rd. This is much appreciated. The Quiet Lanes issue was discussed. There is no legislation covering this as yet but the RCC 'Strategy' Group are looking into this issue. He was asked if he would look into the matter of the sign at the end of Sharrads Way which has been knocked down.

County Cllr. Reid was given thanks for his support in sorting out local matters.

- iv. Cllr. P. Duncan has asked that the matter of the Ordnance survey map used on the Website be discussed. They are asking for a fee of £47.50 be paid for its use.

It was Proposed that the fee of £47.50 be paid for this year and that the details should be obtained from Cllr. P. Duncan.

The matter of the 'Car Port' is now in the hands of the Planning Dept. who are asking for new plans so they can consider the matter.

4. The litter bin on the Recreational Field is the responsibility of the Parish Council and can not be emptied by the RCC.

The Chairman thanked County Cllr. Reid for his help in solving the queries. County Cllr. Reid agreed to support any 'planning' queries that the Council has if he is given notice beforehand.

Mr. Allison reported that nearly all the equipment that has been bought for the field is installed. Crouch for the use of their equipment in moving the soil and digging out foundations which had saved a great deal of money enabling this to be reinvested in the equipment. The field is being well used by families who are enjoying the new facilities. The Parents who have been involved in the erecting of the equipment are now considering putting in a 'Boules Pit' along the edge of the field so that they can join in when the children are using the equipment. They are also considering purchasing some springy animals for the younger children. The money that has been raised should be spent by then and they hope to have everything finished by the school holidays. There has been some petty vandalism, the major one being the prising off the notice giving the names of Donors. This was returned after the theft being announced in the 'Langham News'. The 'Group' will keep going until everything is functioning to their satisfaction.

The following requests were also to be sent to the RCC .1. A reactive speed control should be place on the entry to the village coming from the Oakham area 2. 3. B.T. Payphones are proposing to realign payphone provision to meet consumer demand. After discussion the Council decided as it was practically certain that the payphone box would go so they opted for the Cashless phone box and this will be our answer on the reply form.

4. A letter has been received from the Voluntary Action Rutland informing us that they are the people to approach concerning the clearing of the Brook. They are now in partnership with Ashwell Prison and if we need help with clearing the Brook they will quote us for the job. The Clerk will ask them for a quote to see if their terms are reasonable.
5. ABB have informed us that two new concrete columns are needed in Sharrads Way at the cost of £500 + VAT a column. To transfer the electricity supplies from the old to the new columns will be £514. + VAT. This transfer fee was considered to be very excessive and it was decided to write and ask them to reconsider this price as our consultant electrical engineers considered this charge as 'wholly disproportionate for the work involved'.

The other part of the letter was about the columns in the Churchyard. The Clerk had already informed them that these were not under the control of the Council and that they need to apply to the RCC for any information.

The Chairman on the Council's behalf thanked all the people involved for doing 'a very good job' They and the Village can be very proud of the results.

Mr. Allison also told the Council that there were people who were willing to help check the safety of the equipment on a continuing basis. There will be some money over to help with such things as replacing the bark etc. The only concern he had about the equipment was the possibility of youngsters climbing onto the roof of the shelter which means safety measures and insurance must be taken into consideration by the Council. The Clerk will check whether the insurance covers all the equipment and whether 'public liability' covers the playing field. Mr. Allison said he would supply the Clerk with a full inventory of the new equipment. The Recreational Group is hoping to set up an 'inspection group' to ensure the safety of the equipment, six people are needed for this duty. This is a legal requirement by the Insurance Company.

Cllr. Higgins asked that it be recorded that she was absent on the 29.9.05 owing to the fact that she had a migraine. This was accepted.

p.316 - Loughborough Gds should read Lonsborough Gds.

p.314 - f. 'received a letter' should read 'had a verbal request'

The Minutes were then passed as correct.

Matters Arising Therefrom

1. p.314 b. *We are still waiting for a quote from 'The Voluntary Action Group' concerning the clearing of our part of the brook.*
2. p.314 c. There was good news about the Ruddle Way wall. Cllr. Higgins reported that the wall has been lowered, making entering Burley Rd. less of a hazard. The topping has not been changed but it was felt that as there are other toppings of walls in the area similar to the Ruddle Way wall it should be accepted. The Council has fought hard and long to have the wall lowered and it is now safer.

3. p.315 7. A letter has been sent to Alan Duncan regarding the multitude of signs adorning the roadside and County councillor Reid has asked the Councillors to collate and give him the information regarding the signs that they wish removed or at least put on one pole. They agreed to do this and also to query the colour of the signs as they seem to vary from sign to sign.
4. Cllr. Wright requested that the making of a list of trees needing attention should be undertaken in the Spring and this was accepted.
5. p.314 e Cllr. Wright queried the placing of the bollards on the 'green' as the cars still seemed to be parking on part of the 'green'. The Councillors agreed that they should keep an eye on the situation.
6. p.314 d The History group are still waiting for a new time for the Tallow Chandlers visit.
7. p.318 b The Clerk has enquired about the erection of the building on the old sewage works. Mr. Smith of the Planning Department said that he knew about the building and that they are waiting for retrospective plans to be sent to the Planning Dept. in the near future. The Councillors will make sure that the plans are sent to the Planning dept.
8. p318 f. Cllr. Crouch reported that Langham has been targeted by thieves in the past two weeks and that everybody should be extra careful by putting any tempting items out of sight of prying eyes. Also that all cars and houses should be securely locked.

Correspondence:

- A. A letter from RCC re: Affordable Homes Scrutiny Review Group has been received regarding the Land owned by parish councils, they want to prepare a review report. A reply will be sent stating that the council owns the land off Burley Rd. that is used for Allotments, recreational field, burial ground and Langham Woodlands with no spare land for building houses.
 - B. APLC has sent a notice of several courses they are running. This will be circulated for all Councillors to note.
 - C. RCC 'Rutland together' local strategy group has noted that Langham has no representative. Cllr. Crouch who attends some of their meetings says he will be our Representative and give the Parish Council reports about the group.
 - D. ABB has on request given a report on the safety of the remaining concrete light columns in Langham. They reported that in the next five years 10 columns at least will need changing. An aluminium column on Ranksborough Drive may also deteriorate in the next few years. The current cost to replace a concrete column with new 5 metre steel column complete with a 35 watt sodium lantern controlled by an all night photocell including transferring the electricity service is £507 plus VAT each.

Precept For 2006/7

A paper was presented covering the costing of the 2006/7 Precept

The predicted outgoings were discussed and the increases were discussed.

The grass cutting this year has increased owing to the fact that the weather has caused the grass to keep growing beyond the usual grass cutting months. There is a need to budget for a further 2 cuttings a year. There was agreement that Mr. Hubbard looked after the Village, keeping it looking well cared for.

After the report from ABB concerning the replacing of light columns it is thought necessary to increase the forward costing of street lighting. The RCC does not undertake to pay for replacements only a grant towards the cost of lighting. When the claim form comes in the Clerk will check this to see if there is anyway we can claim for repairs.

This current year we hadn't anticipated paying an extra £1014 on new columns. We now know that at least 10 columns will need replacing in the near future. Most other outgoings will rise a bit during the next year but not to the extent predicted for the two above items. The current years Precept was £10000 and next years, owing to this extra costing, was proposed should be £13500.

This amount is on a par with most Villages of comparable size.

Before asking the Parish Council to accept this proposal the letter from The Village Hall Trustees was discussed. A copy of this letter had been sent to every Councillor two weeks before the meeting so that they had time to peruse and understand the Trustees proposal.

There was general consternation that this proposal had come in such a manner, the Council's representative on the Village Hall committee being just as surprised as the rest of the Council. He had not been informed that a letter of such a nature was being sent to the Council from the Trustees. There had not been any approach informally or otherwise concerning this matter.

During the discussion various points were highlighted. As far as Langham Parish Council is concerned the running of the Village Hall has never been part of their remit. The Council are not aware of having ownership of the Hall and up until now nobody had ever suggested that they did.

The Parish Council and the Trustees of the Village Hall have always been two independent and autonomous bodies. The feeling was that this independence had worked well in the past and should be retained rather than merging as one body. As the Parish Council does not have the terms of the Trusteeship they were not sure that this would be legal. It was noted that the Hall was used by many people other than Village residents and that not all Villagers use the Hall. It was agreed that the Village Hall is an asset for the Village. The Parish Council would support the Trustees efforts to raise money by obtaining grants etc but not to use the Precept to pay for the running costs of the Hall. Other ways of helping were discussed but making an annual grant was not considered desirable. They are however willing to make a grant towards any large projects in keeping the Hall viable. The discussion ended.

The Council turned its attention to passing the proposed Precept for the year 2006/7

There were two proposals concerning the setting of the Precept:

1. That the Precept be set at £14000 for the year 2006/7 which would cover any extra grants.

2. That the Precept be set at £13500 for the year 2006/7 and that any extra grants come out of the Deposit account if necessary.

The first proposal was passed by a majority so 2006/7 Precept will be set at £14000

Any Other Business

A Cllr. Higgins had attended the Parish Forum and gave a report.

Key Points:- Letter from Leicester Police Authority concerning meetings taking place around the Authority.

Community Heritage Project (Presentation 20 mins) Encourage communities to record Biodiversity of area/location.

Rutland Museums service (presentation 20 mins) Need to make partnerships with other groups. Projects : on English Heritage lists to develop clearance of castle walls Educational programmes include early history of poacher in Nether Hambleton. Recycling in Rutland:- Discussion re capacity available – Present situation alright and static. Problems occur in 2010 Landfill sites will be full up.

Anglian Water Proposals – Anglian criticised for launching into interventive proposals when water can be obtained from several sites to produce a nil-change proposal which has not yet been explored. RCC are still weighing up proposals. NB

1. 80 acres (in Anglian proposal) of good farmland are under threat to form 'lagoons'
2. Tourism may be affected by dried out areas.
3. 6000 more migrating birds expected.
4. Need assessment of impact of vehicles and people to move stones etc to Manton over 3 year period

Egleton and Hambleton have put in full objections each 11 pages long.
